

**Minutes of the meeting of District Level Committee for promotion of economic activities and District Level Committee for disposal of individual claims of forest rights under F.R. Act'06 held with DFOs, SDMs and district level officers of line departments in conference hall of office of the D. M. & Collector, South Tripura, Udaipur on 09-03-2011 at 3.00 P.M.**

Members/Officers present in the meeting are shown at Annexure-A.

At the outset, D. M. & Collector welcomed all the members present and initiated discussion. All the members participated in discussion. D.M. stressed upon 100% coverage within a period of two months as per decision of the state level meeting held on 13-01-2011 by the Hon'ble Forest Minister with Chief Secretary, Principal Secretary, Revenue, PCCF and officers of Forest & Revenue departments.

**Decisions taken are as follows:-**

**1. Demarcation of forest lands given to patta holders.**

Sub-division wise 2(two) months action plan covering the period from 20.03.11 to 20.05.11 will be submitted jointly by SDMs & DFOs concerned in advance to the D. M. South on demarcation / re-demarcation of forest land given to the patta holders and noting of co-ordinate based on GPS equipments of Forest Department in the Map/ record of rights for making it more specific. The joint action plan which may be submitted to DM(S) within 19-03-11 should contain the following information:-

- i) Existing trained manpower and requirement of additional trained manpower.
- ii) Available GPS equipments and requirement of additional GPS equipments.
- iii) Formation of TK wise and Mouza wise teams and name, designation of the members of each team.
- iv) Proposed time frame of completion of demarcation etc. works, Mouza wise, T.K. wise.

Demarcation will continue till achievement of 100% coverage attaching priority to the tehsils like Karbook TK, Malbassa TK, Taidu TK, Silachari TK, Bhuratali TK, Killa TK, Matai TK etc. **DFOs and SDMs will monitor it on daily basis and give report to the D.M. from time to time.** To start with, co-ordinates in relation to forest patta land, based on GPS equipments would be noted in the hand sketch Map of patta holders and also in Registers opened for the purpose till further instructions are given by the Govt.

**2. Approval of individual cases of forest right.**

56-cases of individual claims of forest rights under F.R. Act'06 in Santirbazar Sub-Division and 17-cases in Belonia Sub-Division were approved by District Level Committee.

**3. Promotion of economic activities of forest dwellers.**


