Tender should be accompanied by Bank D.Call for Rs. 2000(Two Thousand) only for the vehicle drawn on the State Bank of India /United Bank of India/Gramin Bank of India/Tripura State Co-operative Bank etc . Udaipur/ Sabroom /Santibazar in favour of the Sub-Divisional Magistrate Sabroom, South Tripur as earnest money which is refundable within one month after opening of the tenders.
3. The interested parties willing to purchase the vehicle mentioned above are requested to quote the rate both in words and figures in a sealed cover mentioning value of the condemned vehicle.
4. Quoted auction money should be deposited in full within 7 days from the date of acceptance of the tender by the successful bidders failing which the earnest money deposited by them shall be forfeited.
5. Tax like VAT etc. is applicable as per rules/act.
6. If the 1st highest bidder failed to receive the vehicle within the stipulated date then the next highest bidder chronologically will be preferred.
7. Successful bidder must take physical delivery of the vehicle immediately.
