**NOTICE INVITING FOR SELECTION METHOD FOR SETTLEMENT OF UNSETTLED  
RETAIL VEND OF FOREIGN LIQUOR AND COUNTRY LIQUOR SHOPS.**

It is hereby notified for general information that the licences are proposed to be offered for retail vend of Foreign Liquor and Country Liquor shops within the South Tripura District through selection method for part of the financial year, 2011-12 and 2012-13 under the provisions of Rule 154(b) read with Rule 29A and Rule 22 of the Tripura Excise Rules, 1990.

2. The interested candidate shall remain present expression of interest in sealed cover in the conference hall of O/o the Collector of Excise, South Tripura District, Udaipur at 3.00 pm on 26/07/2011. The sealed cover should indicate the following headings "Notice inviting for selection method for the settlement of retail Foreign Liquor /Country Liquor shop No.F.1(25)-EX/S/2010-11/ 239 dated 20/7/2011"


3. The intending petitioner shall submit along with the following necessary documents:-

- i) Attested copy of Citizenship Certificate/ Permanent Residential Certificate/PAN Card of the petitioner.
- ii) A statement of immovable property alongwith supporting document(s) and current bank balance mentioning name of Bank and Account No. to prove his/her financial ability to carry on the business. A certificate from the concerned Bank Manager about the present bank balance of the bidder mentioning the account No. should also be given.
- iii) The details of the location & description of the building (owned or hired) including all required document(s) of the building including land particulars & in case of hired building a No-Objection Certificate from the owner of the building along with supporting document(s)
- iv) Income Tax, Sales Tax and Professional Tax Clearance Certificate.
- v) The petitioner shall declare that he/she has never been convicted by a criminal court for committing any offence.
- vi) The petitioner shall declare that he/she shall comply with the provisions of Tripura Excise Act, 1987 and Rules, Order, Notification, Executive instruction etc. issued there under.
- vii) The petitioner shall declare that he/she is former licensee but not in any arrears to the Government and his/her conduct has not been found to be unsatisfactory and that he/she never been found guilty of any breach of conditions of licence.

The retail Foreign Liquor and Country liquor shops will be settled through selection method in and around existing sites/locations under the provision of Rule 29A of the Tripura Excise Rules, 1990, for part of the financial year 2011-12 and the financial year 2012-13 and condition as required under the Tripura Excise Act.1987 and Rules made there under.

The successful interested candidate should deposit 50% of total MRF amount through treasury challan within three days settlements from the date of selection as security deposit and balance 50% of amount should deposit before issue of the licence, failing 50% of first deposit as security deposit to be forfeited.
6. After completion of the selection method process the successful petitioner should execute a bond with the Collector of Excise, South Tripura, Udaipur before issue of licence.
7. The Collector of Excise, South Tripura District, Udaipur reserves the right to accept or cancel any petition including the highest one without assigning any reason thereof.
