Southern Division-II, Satchand, South Tripura. Interested owners should quote their rate both in words and figure as per given Annexure-A which may be collected from the office of the undersigned. The tender along with EMD of Rs.3,000/- (Rupees three thousand) only. Will be received in the office of the undersigned on all working days upto 2.30pm of 20-11-10. If possible the Tender box may be opened on 20-11-10 at 3.00pm.

Terms & Conditions

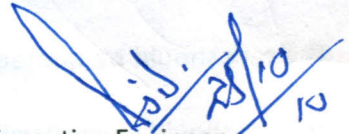
1. The rate should be quoted for detention per day and rate per Km in the form prescribed in Annexure-A.
2. The car should have all valid documents as well as commercial license as per Motor Vehicle Act.
3. The car should be placed within 10(ten) days from the date of final order.
4. The vehicle should be provided with all necessary accessories.
5. The Kilometer reading/Odometer of the vehicle should always remain operational.
6. The driver shall maintain Log Book and have to be signed by the officer using the vehicle.
7. The vehicle placed for duties shall always be in fit condition. In case of vehicle becomes unfit or goes for repair, the owner shall be responsible for arrangement of substitute vehicle in good condition.
8. Plate with words "ON GOVT DUTY" shall be used on the vehicle. It shall never be allowed to be used by any person without prior permission of the undersigned.
9. Earnest money of Rs.3,000/- (Rupees three thousand) only. is to be deposited along with tender paper without which the tender will be rejected.
10. The undersigned reserves the right to reject any rate including the lowest one without assigning any reason.
11. Payment of hiring charge will be made against bill raised by the supplier supported by appropriate certificate from the user, and on availability of fund.
12. Tax will be deducted as per rule.
13. The office shall not be responsible for any damage to the vehicle in case of accident or otherwise, theft of vehicle/ parts and accessories. Similarly this office shall not be responsible for any third party claims. This office shall not be responsible for any challan for disobeying of any traffic rules by the driver.
14. The vehicle should be available at any hour of the day including holidays if desired by the undersigned.
15. The period of hiring of the vehicle will be of 01(one) year tentatively from the day of contract.
16. The driver should always remain present with the vehicle during the entire period of duty. The driver should not be changed frequently unless desired by the undersigned.

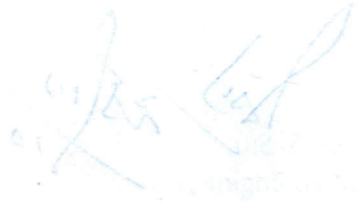
